

TRANSPORTATION AGREEMENT 2018-2019

Parents and Students:

Each student's safety is of paramount importance to us, as we are sure it is to you. Cardinal Gibbons is pleased to provide bus transportation to your son/daughter for this upcoming school year. SCHOOL BUS RULES AND REGULATIONS

1. **Be in your seat at all times.**
2. **Throwing objects outside/inside the bus is strictly prohibited.**
3. **Yelling or shouting will not be tolerated.**
4. **Students must be polite and courteous to bus drivers at all times. STUDENTS MUST FOLLOW ALL DIRECTIVES GIVEN BY THE BUS DRIVER.**
5. **The bus driver reserves the right to move a student's seat if that student is acting in a disruptive manner.**
6. **There will be absolutely no tampering with bus equipment, doors, windows, gears, etc. at any time --- especially when waiting for departure.**
7. **No standing up or walking around the bus during transit.**
8. **Students must be polite and courteous to one another. No teasing or harassing.**
9. **Students must be prompt for all pick-ups (in plain sight of the bus driver) and departures.**
10. **Students must take their seats immediately and remain there for the duration of the trip.**
11. **The bus driver and director of transportation reserve the right to suspend or expel a student from riding the bus.**
12. **There will be no moving or touching anyone else's property.**
13. **Pranks are strictly prohibited.**
14. **No eating, drinking, or gum chewing.**
15. **Students must be picked up and dropped off at the location originally requested. If the student is to be picked up or dropped off at a different location, a written request must be sent to the office in advance.**
16. **Only students who are under contract may use the buses. Friends are not permitted to use the am or pm school transportation.**

By signing below, I/we agree to abide by all of the above rules and regulations. We clearly understand that infractions may result in suspension or termination of transportation services. I also agree that I am responsible for the yearly contract amount in full regardless of whether or not my son/daughter rides the bus for the entire year or terminates such riding for any reason whatsoever.

TRANSPORTATION CONTRACT

If you plan to have your son/daughter ride one of our buses, it will be necessary for you to complete and sign the *Transportation Contract Form* below and the *Transportation Agreement on the reverse side*. Return this form with the necessary payment no later than June 22, 2018. **PLEASE NOTE:** We do not give door-to-door service. Please check the attached list of pick-up locations and indicate your selection for student pick-up and/or drop off in the pm. The bus supervisor will be in touch with you as to the time of the pick-up and exact pick-up location just prior to the beginning of school.

- Cost of Transportation per student:
- a) One Way - \$900.00 per school year
 - b) Both Ways - \$1,300.00 per school year

*** There are no family plan tickets and no discount for multiple students***

PLEASE READ THE FOLLOWING CAREFULLY - Once a transportation contract has been processed, parents are responsible to pay for the entire year. We have had parents in the past that changed their minds and decided to carpool or drive their students to school. We must insist that payment be made for the full year. It is not equitable that parents whose students do not use the bus service be charged indirectly for this service by having to make up losses through their tuition payments. The transportation program must be self-supporting. Your signature below indicates that you agree to pay for the entire year whether or not your student continues to use this service.

Seats are sold on a first-come first-serve basis. No refunds will be made for any reason after August 10, 2018. A \$25.00 service charge will be assessed for contracts cancelled prior to August 10, 2018. If there is any change in the bus schedule, the bus supervisor will contact you some time before school starts. For this reason, it is important that you indicate a telephone number on this application where you can be reached.

We must have a separate contract for each student please.
